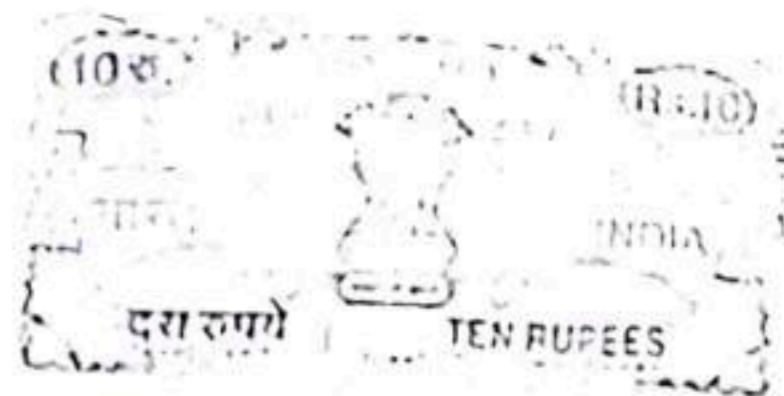


# LAND CERTIFICATE
